International Solar Alliance (ISA)

- The International Solar Alliance (ISA), an Indian initiative, was launched jointly Prime Minister of India and President of France in Paris, France on the side-lines of the 21st Conference of Parties (CoP 21) to the United Nations Framework Convention on Climate Change.
- The Alliance, recognising that solar energy provides potential member solar resource rich countries lying fully or partially between the Tropics of Cancer and Capricorn, with an unprecedented opportunity to bring prosperity, energy security and sustainable development to their peoples, opened ISA Framework Agreement for signature on 15 November 2016 in Marrakech, Morocco, on the side-lines of COP-22.
- In conformity with the ISA Framework Agreement, 30 days after ratification by the 15th country, on 6 December 2017, ISA became the first full-fledged treaty based international intergovernmental organization headquartered in India.
- Through this initiative, the countries, inter alia, share the collective ambition:
 - $\circ\,$ To address obstacles that stand in the way of rapid and massive scale-up of solar energy.
 - To undertake innovative and concerted efforts for reducing the cost of finance and cost of technology for immediate deployment of competitive solar generation, mobilise more than 1000 Billion US Dollars of investments by 2030.

Financial Inclusion Index

- The Union Minister of Finance and Corporate Affairs, launched the Financial Inclusion Index after his Annual Performance Review Meeting with CEOs of the Public Sector Banks in New Delhi today.
- Department of Financial Services (DFS), Ministry of Finance will release an Annual Financial Inclusion Index (FII) which will be a measure of access and usage of a basket of formal financial products and services that includes savings, remittances, credit, insurance and pension products.
- The index will have three measurement dimensions;
 - $\circ\,$ Access to financial services

- Usage of financial services
- \circ Quality.

Purpose and Function

- The single composite index gives a snap shot of level of financial inclusion that would guide Macro Policy perspective.
- The various components of the index will also help to measure financial services for use of internal policy making.
- Financial Inclusion Index can be used directly as a composite measure in development indicators.
- It enables fulfilment of G20 Financial Inclusion Indicators requirements.
- It will also facilitate researchers to study the impact of financial inclusion and other macro-economic variables.

Parakram Parv

Countering Corruption

- The DAC structure ensures that there are in-built checks and balances in relation to procurements.
- For instance, the armed forces are well represented, ensuring that the defence bureaucracy does not exercise overwhelming influence on decision- making.
- The adequate mix of bureaucracy and service officers is also reflected in other bodies involved in acquisition, under the overall supervision of the DAC.

Functions of DAC:

- Will give policy guidelines to acquisitions, based on long-term procurement plans
- Will also clear all acquisitions, including imported equipment and those produced indigenously or under a foreign licence
